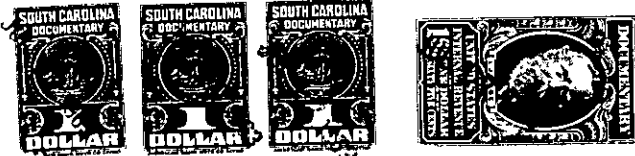

K. Campbell, R.L.S., dated July 9, 1962, and recorded in the Office of the R.M.C. for said County and State in Plat Book "QQ", Page 168, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the eastern side of said Road, joint front corner of Lots 156 and 157, and running thence S. 65-19 E. 125.2 feet along the joint line of said lots to an iron pin, joint rear corner of said lots and Lots 148 and 149; thence N. 17-28 E. 73.5 feet along the joint line of Lots 157 and 148 to an iron pin, joint rear corner of said lots and Lots 147 and 158; thence N. 64-17 W. 116.1 feet along the joint line of Lots 157 and 158 to an iron pin on the eastern side of said Road, joint front corner of said lots; thence S. 23-46 W. 75 feet along the eastern side of said Road to an iron pin, the point of beginning.
