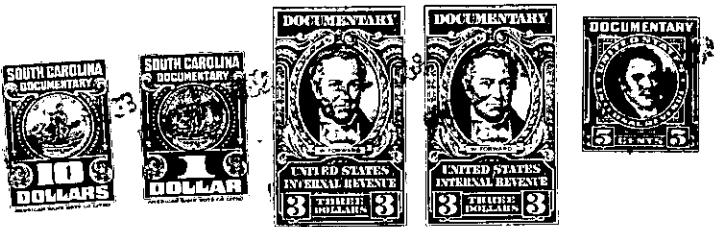

A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of Five Thousand Two Hundred Fifty and No/100 Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto James L. Cauble, Jr., his heirs and assigns forever:

All that certain lot of land lying in Greenville County, State of South Carolina on the Southwestern side of Bridgewater Drive, shown as Lot No. 180 on a plat of Botany Woods, Sector IV recorded in the R. M. C. Office for Greenville County in Plat Book YY at Page 23 and being further described as follows:

BEGINNING at an iron pin on the Southwestern side of Bridgewater Drive at the joint front corner of Lot Nos. 179 and 180 and running thence along the line of Lot No. 179, S. 36-33 W. 153.0 feet to an iron pin in the line of property designated as Cherokee Park; thence along Cherokee Park Property, S. 56-50 E. 106.9 feet to an iron pin at the corner of Lot No. 181; thence along the line of Lot No. 181 N. 57-43 E. 147.7 feet to an iron pin on the Southwestern side of Bridgewater Drive; thence along Bridgewater Drive, N. 41-41 W. 35.0 feet; thence continuing along Bridgewater Drive, N. 52-05 W 47.8 feet; thence continuing along the said drive, N. 53-27 W. 77.2 feet to the point of beginning.
