

All that piece, parcel or tract of land situate, lying and being in Greenville County, South Carolina and being a portion of Tract No. 5, plat No. 4 of the J. F. Freeman property recorded in the RMC Office for Greenville County in Plat Book G, Page 253 and having, according to a recent survey, dated August 2 1963, prepared by Piedmont Engineers & Architects, recorded in Plat Book <u>CPC</u> dated August 2, 199, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Old Spartanburg Road at a joint corner of a tract retained by grantor, which point is 50 feet N. 70-30 E. from the joint front corner of this property and a tract owned, now or formerly by Howell, and running thence with the line of the tract retained by grantor S. 17-55 W. 301.9 feet to a point; thence S. 20-26 W. 178 feet to a point; thence N. 558-57 E. 197.1 feet to a point in the line of property, now or formerly of C. L. Dillard; thence with said line S. 13-00 W. 228.2 feet to a point; thence continuing with said tract S. 50-15 E. 336 feet, more or less, to a point in the center of Brushy Creek; thence with the center of said creek, the traverse of which is S. 81-30 W. 545 feet to a point; thence continuing with the center of said creek, the traverse of which is N. 87-04 W. 446.7 feet to a point in the line of property, now or formerly of Watson; thence with the Watson line N. 52-30 E. 570 feet to a point; thence N. 23-29 E. 140.2 feet to a point in branch; thence with the branch as the line, the traverse of which is N. 25-30 E. 200.9 feet; thence continuing with the center of said branch N. 20-09 E. 278.4 feet to a point on the southerly side of Old Spartanburg Road; thence with said road N. 70-30 E. 50 feet to the point of beginning and containing, according to said survey, 6.4 acres, more or less, and being a portion of property conveyed to grantor herein by deed recorded in Deed Book 398, Page 17.
