- 6. No noxious or offensive trade or activity shall be carried on upon any of the lots in this subdivision nor shall anything be done. thereon which may be or may become an annoyance to the neighborhood.
- 7. Easements for the installation and maintenance of utility and drainage facilities are reserved as shown on the recorded plat, and along the side and rear lines of each lot.
- 8. The purchaser of each lot shall be entitled to one tap on the water main in front of the lot purchased, which tap shall be used for domestic purposes. All taps shall be at the purchaser's expense and subject to the regulations of the Greenville City Water Works.
 - 9. No Paultry or livestock shall be kept on any lot.
- 10. All sewer disposal shall meet the requirements of the State Board of Health.
