Know All Men by These Presents:

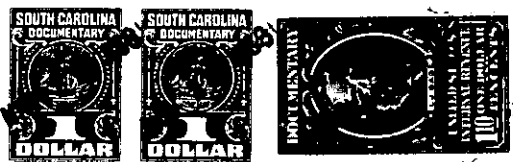
That I, James O. Childress in the State aforesaid, in consideration of the sum of One Thousand (\$1,000.00) DOLLARS,

C., and having according to said plat the following metes and bounds, to-wit:
