STEWART AND LOUISE McLAURIN STEWART:

All that certain piece, parcel or lot of land situate, lying and being on the Northeastern side of Hathaway Circle, in Paris Mountain Township, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 93 as shown on a plat of Stratford Forest, prepared by Piedmont Engineering Service, dated February 25, 1957, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK at page 89, and as shown on a revision of Lots 93 and 94, Stratford Forest, prepared by Piedmont Engineers and Architects, dated December 3, 1963, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK at page 88, and having according to the last mentioned plat, the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Hathaway Circle at the joint front corner of Lots Nos. 92 and 93, and running thence with the line of Lot No. 92 N. 43-40 E. 268.8 feet to an iron pin in or near a branch and in the subdivision property line; thence with the branch as the line, having a traverse line as follows: N. 43-46 W. 127.8 feet to an iron pin, thence N. 57-20 W. 92.1 feet to an iron pin, which iron pin is located S. 37-08 W. 10 feet from the center line of said branch; thence from the center line of said branch and with the line of Lot No. 94 S. 37-08 W. 279.5 feet to an iron pin on the Northeastern side of Hathaway Circle; thence with the Northeastern side of Hathaway Circle S. 50-21 E. 187.9 feet to the point of beginning.
