CHARTER BY THE SECRETARY OF STATE

WHEREAS,

J. C. Hubert and Ovie Ivester

of

5800 Augusta Road, Greenville, S. C. DEC 19 9 32 AM 1963

did on the 17th day of December, 19 63, file with the Secretary of State a written Declaration signed by themselves, setting forth:

FIRST That their names and residences are as above given.

SECOND: That the name of the proposed corporation is RECLINERS MFG. CO. INC.

THIRD: That the principal place of business is 5800 Augusta Road, Greenville, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to manufacture, build and construct; cabinets, chairs, desks, furniture and other items pertaining to the manufacturing of woodcraft products, and to buy, sell, lease, acquire, hold, finance, mortgage and convey real estate and personal property. Purchase the business, good will and all other assets of any individual, firm or corporation as a going concern and to assume all its obligations and generally to perform all acts authorized for corporations under the laws of South Carolina, and to perform any acts which may be deemed necessary, or expedient pursuant to and in connection with the foregoing objects and powers.

FIFTH: That the amount of the capital stock is Twenty Thousand (\$20,000.00) Dollars payable cash

SIXTH: That the number of shares into which the capital stock is divided is Four Thousand (4,000) of the par value of Five (\$5.00) Dollars

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 12th day of December, 19 63, at which a majority of all stock in value being present in person or by proxy, the following were elected directors: J. C. Hubert Ivester, Ovie Ivester

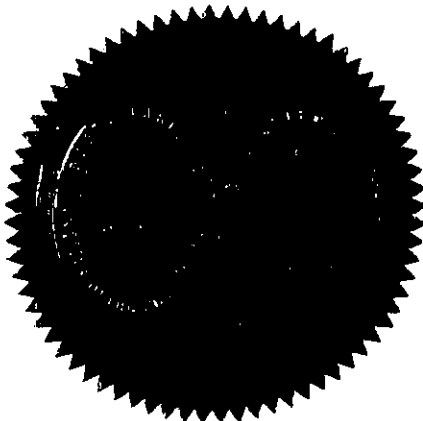
EIGHTH: That subsequently there was elected as President, J. C. Hubert Ivester; as Vice-President, Ovie Ivester; as Secretary, Ovie Ivester; as Treasurer, J. C. Hubert Ivester

NINTH: That all requirements of Title 12, Article 1, Chapter 2, Code of Laws of South Carolina, 1952, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in Greenville News

a newspaper published in the County of Greenville

NOW, THEREFORE, I, O. FRANK THORNTON, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
