COUNTY OF GREENVILLE) DEED TO RIGHT-OF-WAY AND RELEASE AGREEMENT

Know All Men by These Presents That WE, BRUCE SMITH and PAULINE SMITH

of said County and State, for and in consideration of the premises, and of the sum of Six Hundred Sixty-Five and No/100 (\$665.00)-----Dollars

to us in hand paid by THE CITY OF GREENVILLE, SOUTH CAROLINA, the receipt whereof is hereby acknowledged, do hereby grant unto the said THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, the right, privileges and easement to go in and upon that tract of land, situated in Butler Township, in the said County and State, bounded by lands of W. H. Smith, G. Alvin and Mary V. Robinson, and a county road. The property affected by this right of way is the same property conveyed to Bruce Smith and Pauline Smith by deed of W. H. Smith, dated April 5, 1947, recorded in the RMC Office for Greenville County, S. C. in Deed Book 310, Page 90.

* That the permanent right of way after the pipe line or lines are installed shall lie 25 feet East of the center of said pipe line as laid, and no obstruction shall hereafter be placed on said 25 foot right of way.

and to construct and maintain in, upon and through said premises, in a proper manner, a pipe line or lines, air vents, blow off connections, manholes and other necessary apparatus incident thereto, using the necessary appliances and machinery for such work for the purpose of conveying water through the premises above described, together with the right at all times to enter upon said premises for the purpose of inspecting said line or lines and making necessary repairs and alterations thereon, together with the right to cut away and keep clear of said pipe line or lines all trees and other obstructions that may in any way endanger or interfere with the proper operation of or access to the same.

and as permanent is to be twenty-five

It is understood and agreed that the right of way to be used under this contract during construction/~~not to exceed~~ feet in width throughout the entire length which is approximately 302 feet, and the damage, which THE CITY OF GREENVILLE, SOUTH CAROLINA, is to be liable for during construction, is to be confined to this strip and nothing beyond. The location of the pipe line or lines, when laid, will determine the definite location of the right of way. The center of the pipe line or lines shall be accepted as lying twenty-five feet from the East boundary line of this right of way. The ~~remainder~~ remainder of said right of way during construction shall lie West of the center of said pipe line or lines and the entire right of way may be used for the purpose of installing the pipe line or lines. The location of said pipe line or lines is to be approximately along the line as now located and staked out by the engineers, subject to a variation of not exceeding five feet either way. ~~The same right of way, when the pipe line or lines are laid, shall be placed to be twenty-five feet from the center of said pipe line or lines, and no obstruction shall hereafter be placed on said 25 foot right of way.~~ *See above

If in laying the pipe line or lines, it is necessary to cut any timber from the right of way, such timber shall be placed at the edge of the right of way on the land of the undersigned grantor and shall be the property of the undersigned grantor.

It is further understood that the owner is to have the right to cultivate and use this right of way strip of land provided such use there-of shall not interfere with the proper maintenance and free access to the pipe line or lines to be installed under this agreement. No buildings or other structures shall be placed on said right of way nearer than 25 feet from the center of said pipe line or lines.

The payment above specified covers compensation for the easement or right of way, and also covers all claims for damages, including crops growing on the right of way during ~~the period of~~ construction along said right of way resulting from construction of the pipe line or lines to be laid.

It is further agreed that in case of future damages to property or crop, due from an accident on the pipe line that THE CITY OF GREENVILLE shall pay all damages.

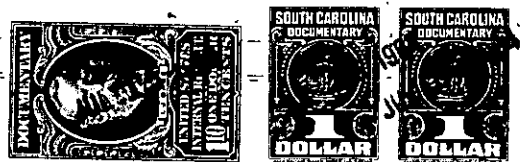
