C., being shown as Lot No. 6 on Plat of Wade Hampton Gardens, made by Dalton & Neves, Engineers, dated March, 1961, recorded in Plat Book MM, Page 199, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Flamingo Drive, at joint front corner of Lots 5 and 6 and runs thence along the line of Lot 5, S. 27-17 W., 187.4 feet to an iron pin; thence N. 62-25 W. 100 feet to an iron pin; thence with the line of Lot 7, N. 27-17 W., 186.9 feet to an iron pin on the Southwest side of Flamingo Drive; thence along Flamingo Drive, N. 62-43 E. 100 feet to the beginning corner.
