KNOW ALL MEN BY THESE PRESENTS, that We, Donald E. Norris and Patricia L. Norris, of Greenville County,

in consideration of Fifteen Hundred and 00/100 (\$1500.00) Dollars and assumption of mortgage / matters

receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and released Edith A. Sayer, her heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot #22 of a subdivision known as Club View Heights, according to a plat thereof prepared September, 1956 by C. C. Jones and Associates, Engineers, and recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 145 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Traynham Boulevard at the joint front corner of Lots #22 and #23 and running thence along joint line of said lots, N. 62-52 E. 170 feet to an iron pin in the line of Lot #24; thence along line of Lot #24, S. 40-10 E. 41.4 feet to an iron pin in the line of Lot #20; thence along line of Lot #20, S. 18-48 E. 60.2 feet to an iron pin at the joint rear corner of Lots #22 and #21 and running thence along joint line of said lots, S. 62-52 W. 170 feet to an iron pin on the eastern side of Traynham Boulevard; thence with the eastern side of said Traynham Boulevard, N. 27-08 W. 100 feet to the point of beginning; being the same property conveyed to us by George Peterson by his deed dated August 16, 1962, and recorded in the R. M. C. Office for Greenville County in Deed Volume 704, at Page 424.

As a part of the consideration for this conveyance, the grantee expressly assumes and agrees to pay the balance due on that certain note and mortgage, in the original sum of \$14, 150.00 executed by the grantors to the First Federal Savings & Loan Association of Greenville and recorded in the R. M. C. Office for Greenville County in Mortgage Book 898, at Page 465, the balance due thereon being the sum of \$13,447.50 as of this date.

The grantors agree to surrender possession of the above described premises on or before August 20, 1964.
