BEGINNING at an iron pin on Altamont Road, which pin is 861.6 feet northeast of the intersection of Woodhaven Drive, and running thence along Altamont Road, North 28-01 East 180 feet to an iron pin; thence by a new line North 82-50 East 292.5 feet to an iron pin; thence South 12-09 West 200 feet to an iron pin; thence South 86-49 West 320 feet to an iron pin; thence by a curved line, having a chord of North 38-02 West 22.8 feet to the beginning corner.

A portion of the above described property is a part of a tract of land conveyed by Furman University to E. D. Harrell, Jr. and Allen L. Harrison by deed dated June 6, 1953 in Deed Volume 481 at page 229. Subsequently by a deed dated April 9, 1954 and recorded in Deed Volume 507 at page 1, said E.D. Harrell, Jr. and L. G. Causey conveyed all of the above described property to Catherine Helene Wells and Jesse B. Wells, thereby vesting in them a fee simple title to all of said property with the exception of an outstanding one-half interest in Allen L. Harrison to a small portion thereof. By deed dated August 6, 1955 and recorded in Deed Volume 532 at page 39, one E. Allen Harrison, who is the same person as Allen L. Harrison, conveyed to Luther G. Causey as trustee for Nancy J. Causey, a certain tract of land that included the one-half interest in a small portion of the above described property. Subsequently, by deed dated October 21, 1961 and recorded in Deed Volume 693 at page 158, said Luther G. Causey as Trustee for Nancy J. Causey conveyed all his right, title, and interest in all lands held in trust to Nancy J. Causey, thereby vesting in her an undivided one-half interest in a small portion of the above described property. This deed is executed to vest in the grantee a full fee simple title in all of the above described property.
