## RIGHT OF WAY AGREEMENT

KNOW ALL MEN BY THESE PRESENTS that for and in consideration of the sum of Three Hundred, Seventy-five Dollars (\$375.00), paid to J. D. Hollingsworth (hereinafter designated Grantor), the receipt of which is hereby acknowledged, the Grantor hereby bargains, sells and conveys unto Piedmont Natural Gas Company, Incorporated, a New York corporation (hereinafter designated Grantee), and its successors and assignees, a right-of-way and easement for the purposes of laying, constructing, maintaining, operating, repairing, altering, replacing and removing a pipe line (with valves, regulators, meters, fittings, appliances, tie-overs, and appurtenant facilities) for the transportation of gas, oil, petroleum products, or any other liquids, gases, or substances which can be transported through a pipe line, under, upon, over, through and across the lands in which the Grantor has an interest situate in Greenville County, South Carolina and, according to plat of a proposed easement along Old Woodruff Road for Piedmont Natural Gas Company, Incorporated, dated June 30, 1964 and surveyed by R. K. Campbell and H. C. Clarkson, described as follows:
