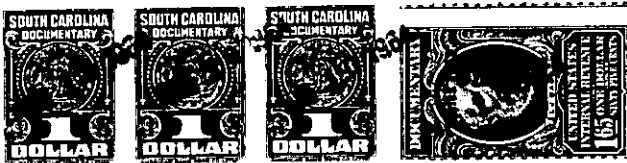
in consideration of Fifteen Hundred and no/100-----(\$1500.00)---Dollars,

All that piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as lot #48, of a subdivision known as Thornwood Acres, as shown on a plat prepared by Jones & Sutherland Engineers, dated December 1, 1958, entitled "Final Subdivision Layout Thornwood Acres" property of Williams Land Co., Inc. and recorded in the R.M.C. Office for Greenville County in Plat Book MM, at Page 59, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of lots #48 and #49 and running thence S40-52W 170' to an iron pin; thence running N17-28W 91.6' to an iron pin at the joint rear corner of lots #48 and #47 and running thence N37-37E 122.2' to an iron pin on the southern side of Brushy Creek Road; thence along the southern side of Brushy Creek Road S49-08E 85' to an iron pin, point of beginning.
