All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 11 of a subdivision known as Sheffield Forest according to a plat thereof prepared by Carolina Engineering and Surveying Company, March 21, 1962 and recorded in the R. M. C. Office for Greenville County in Plat Book AAA, at Page 47, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Confederate Avenue at the joint front corner of Lots Nos. 10 and 11, and running thence with the joint line of said lots, N. 6-0 W. 150 feet to an iron pin in the rear line of Lot No. 6; thence with the rear line of Lots Nos. 6 and 5, S. 84-00 W. 100 feet to an iron pin at the joint rear corner of Lots Nos. 11 and 12; thence with the joint line of said lots, S. 6-00 E. 150 feet to an iron pin on the northern side of Confederate Avenue, joint front corner of Lots Nos. 11 and 12; thence with the northern side of said Confederate Avenue, N. 84-00 E. 100 feet to the point of beginning;
