Taylor, as Trustees of Francis Asbury Methodist Church, in Trust, for the purposes hereinafter set forth below, their successors and assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southwesterly side of Lullwater Road in the City of Greenville, S.
