in consideration of TWO THOUSAND AND NO/100-----(\$2,000.00)----- Dollars,

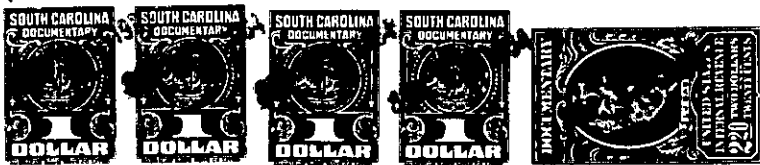

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 48 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book XX at Page 9, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Fairfax Drive at the joint front corner of Lots 47 and 48 and running thence with the Southeastern side of Fairfax Drive S 59-43 W 15.6 feet to a point; thence continuing with the Southeastern side of Fairfax Drive S 58-53 W 114.4 feet to a point; thence following the curvature of the Southeastern intersection of Fairfax Drive with Penarth Street (the chord of which is S 13-53 W 28.3 feet) to a point; thence with the Northeastern side of Penarth Street S 31-07 E 155 feet to a point at the joint front corner of Lots 48 and 49; thence N 58-53 E 150 feet to a point at the joint rear corner of Lots 47 and 48; thence N 31-07 W 174.8 feet to the point of BEGINNING.
