Gordon C. Spearman, his heirs and assigns forever:

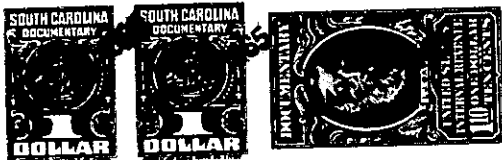
