2. That portion of the electric transmission line of Carolina Power & Light Company which extends northwardly from the substation at Greenville, South Carolina, above described, to the Davidson River Substation of Duke Power Company (specifically to the point at which the facilities of the line dead-end on the 100 KV bus structure of Duke Power Company within said substation), near Brevard, North Carolina, a distance of 31.26 miles, together with all rights of way and easements appurtenant thereto, including but not limited to (a) the lands and interests in lands presently owned by Carolina Power & Light Company by virtue of the conveyance made to it by a deed of Duke Power Company, dated December 5, 1928, and recorded in Book 147, Page 567, in the office of the R. M. C. of Greenville County, South Carolina; (b) the rights of way. and easement rights granted to Carolina Power & Light Company by the following instruments which appear of record in the offices of the Register of Mesne Conveyances of Greenville County, South Carolina, and the Register of Deeds of Transylvania County, North Carolina, as indicated:
