All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 44, Block E, Paris Heights, as per plat thereof recorded in the RMC Office for Greenville County, South Carolina, in Plat Book Y, page 65, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on Pisgah Court, joint front corner of Lots 43 and 44, and running thence S 16-12 E 96.2 feet to an iron pin; thence S 72-30 W 25 feet to a point; thence S 86-58 W 117.5 feet to an iron pin, common corner Lots 24, 44, 45 and 47; thence N 26-43 E 139.2 feet to an iron pin on Pisgah Court; thence following the curve of Pisgah Court, the chord of which is S 69-04 E 55 feet to an iron pin, the point of beginning.
