the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JOHN H. BOWLES AND JOYCE H. BOWLES, Their Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, near Travelers Rest, and being known and designated as Lots Numbers 13 and 14 as shown on a revised map of Tracts 58, 59 and 60 of a subdivision known as Meadowbrook Farms, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book VV at Page 51, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of Loraine Drive at the joint front corner of Lots 12 and 13 and running thence with the Eastern side of Loraine Drive S 27 - 24 E 45.4 feet to a point; thence continuing with the Eastern side of Loraine Drive S 12 - 18 E 35 feet to a point at the joint front corner of Lots 13 and 14; thence still continuing with the Eastern side of Loraine Drive S 12 - 18 E 100 feet to a point at the joint front corner of Lots 14 and 15; thence N 77 - 42 E 175 feet to a point at the joint rear corner of Lots 14 and 15; thence N 12 - 18 W 100 feet to a point at the joint rear corner of Lots 13 and 14; thence N 12 - 18 W 200.7 feet to a point at the joint rear corner of Lots 12 and 13; thence S 44 - 35 W 223.1 feet to a point on the Eastern side of Loraine Drive, the point of BEGINNING.
