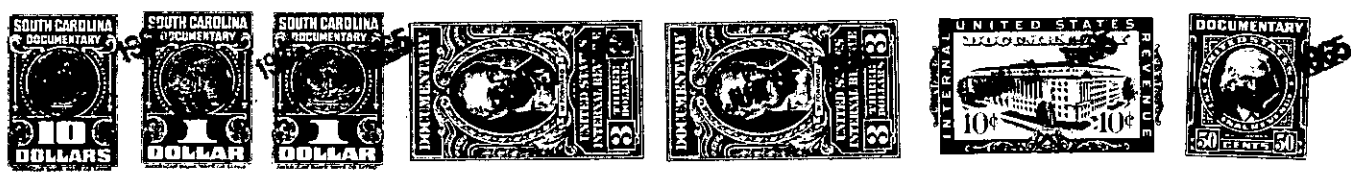

ALL THAT PIECE, PARCEL OR TRACT OF LAND SITUATE, LYING AND BEING IN DUNKLIN TOWNSHIP, GREENVILLE COUNTY, SOUTH CAROLINA, BEING KNOWN AND DESIGNATED AS THE 24.65 ACRE TRACT OF LAND AS SHOWN ON A PLAT OF "PROPERTY OF MITCHELL C. MOORE," PREPARED BY DALTON & NEVES, ENGINEERS, DATED APRIL 1941, AND RECORDED IN THE RMC OFFICE FOR GREENVILLE COUNTY, SOUTH CAROLINA, IN PLAT BOOK 00 AT PAGE 163, AND BEING A PORTION OF TRACT NO. 2 OF THE HYRAM COOLEY ESTATE, AS SURVEYED AND PLATTED BY W.
