All that certain parcel or lots of land on the north side of the dual lane Highway No. 29 near Chick Springs, Greenville County, State of South Carolina, and being Lots Nos. 7 and 8 of the Flynn Estates, Development No. 1, according to survey and plat by H. S. Brockman, Surveyor, dated July 3, 1953, recorded in Plat Book "W", page 195, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

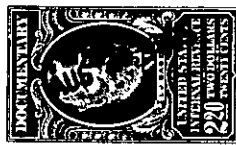
