All that certain piece, parcel or lot of land on the Eastern side of Capers Street in the City of Greenville, County of Greenville, State of South Carolina and being shown as the rear portion of lots 21 and 20 on plat of Crescent Terrace, recorded in the R. M. C. Office for Greenville County in Plat Book E at Page 137, and being more particularly described as follows:
