All that piece, parcel or lot of land situate, lying and being at the Northwestern corner of the intersection of Wakewood Way and Pennwood Lane near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 52 as shown on plat of Imperial Hills, prepared by C. C. Jones, dated August, 1964, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB at page 35, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Pennwood Lane at the joint front corners of Lots Nos. 51 and 52 and running thence with the line of Lot No. 51 N. 27-30 W. 182.5 feet to an iron pin at the joint rear corners of Lots Nos. 52 and 34; thence with the line of Lot No. 34 N. 84-36 E. 145feet to an iron pin on the Western side of Wakewood Way; thence with the Western side of Wakewood Way S. 12-45 E. 55 feet to an iron pin; thence continuing with the Western side of Wakewood Way S. 22-37 E. 55 feet to an iron pin; thence with the curve of the intersection of Wakewood Way and Pennwood Lane, the chord of which is S. 17-30 W. 28.2 feet to an iron pin on the Northern side of Pennwood Lane; thence with the Northern side of Pennwood Lane S. 62-30 W. 95 feet to the point of beginning.
