All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, being known as Lot No. 14 CHISOLM TRAIL, of Section 2, Parkins Lake Development near Greenville, S. C. according to a plat made October 22, 1962 by R. K. Campbell, Engineer and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "YY", Page 93 and being more particularly described as follows:
