the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Azalee Elizabeth Hunt, her heirs and assigns forever all that piece, parcel or lot of land, situate, lying and being near the City of Greenville in the County of Greenville, State of South Carolina, being known and designated as lot # 4, Property of Florence Rollison, plat of which was prepared in May 1950 by R. H. Campbell, Surveyor, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southerly side of a twenty-foot reserved driveway, joint front corner Lots # 3 and # 4 of the said property, which iron pin is approximately 316 feet in an Easterly direction from the center of Worley Road, and running thence S. 2-30 W. 159.3 feet to an iron pin, joint rear corner Lots # 3 and # 4; thence S. 87-30 E. 66 feet to an iron pin, joint rear corner Lots # 4 and # 5; thence N. 2-30 E. 159.3 feet to an iron pin on the Southerly side of a twenty-foot reserved driveway; thence along the said reserved driveway N. 87-30 W. 66 feet to an iron pin, the point of beginning.

This is a part of the property conveyed to the Grantor herein by Lula Raines Higginbotham by deed dated Nov. 3, 1934 and recorded in the R. M. C. Office for Greenville County, South Carolina in Deeds Volume 176 at page 187. Also this property was conveyed to Joe Cunningham and Rebecca Rollison Cunningham by Florence Rollison by deed dated June 10, 1950 for life and recorded in Vol 412 page 109 in the R. M. C. Office for Greenville County, S. C. and the grantor herein is conveying to the grantee herein her reversionary interest in the said land.
