to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto **WILMER R. VOLNOGLE AND MARJORIE C. VOLNOGLE:**

All that piece, parcel or lot of land situate, lying and being at the North-western corner of the intersection of Welcome View Drive and Stevenson Lane near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 3 as shown on a plat prepared by Dalton & Neves, Engineers, dated January, 1965, entitled "Property of Dempsey Construction Co., Inc.", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book III at page 127, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin at the Northwestern corner of the intersection of Welcome View Drive and Stevenson Lane, and running thence with the Northern side of Stevenson Lane S. 63-46 W. 160.55 feet to an iron pin at the joint corner of Lots Nos. 3 and 4; thence with the line of Lot No. 4 N. 31-0 W. 86.63 feet to an iron pin at the joint rear corner of Lots Nos. 2 and 3; thence with the line of Lot No. 2 N. 59-0 E. 160 feet to an iron pin on the Western side of Welcome View Drive; thence with the Western side of Welcome View Drive S. 31-0 E. 100 feet to the point of beginning.
