release unto H. O. Moody

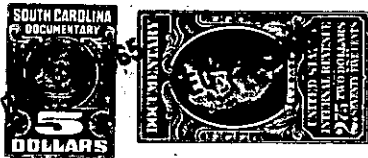
his, her or their heirs or assigns forever:
