in consideration of Forty-Nine Hundred Fifty and No/100 (\$4, 950.00) ----- Dollars, and assumption of mortgages set out below the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Frances B. Arrowood, her heirs and assigns forever:

All that piece, parcel or lot of land, with the improvements thereon, situate, lying and being in or near Greenville, in the County of Greenville, South Carolina, and being more particularly described as Lot No. 304, Section 2, as shown on plat entitled "Subdivision for Abney Mills, Brandon Plant, Greenville, South Carolina," made by Dalton & Neves, Engineers, Greenville, S. M. C. Office for Greenville County in Mortgage Book 792 at page 13, having a balance due as of this date of \$2, 539.32 .

As a further part of the consideration for this conveyance, the grantee expressly assumes and agrees to pay the balance due on a certain real property agreement given by the grantors to Citizens & Southern National Bank recorded in the R. M. C. Office for Greenville County in Deed Vol. 744 at Page 248 , which balance is \$880.70 as of this date. The grantee further agrees to pay the balance due on a Home Improvement Loan with South Carolina National Bank having a balance this date of \$547.93.
