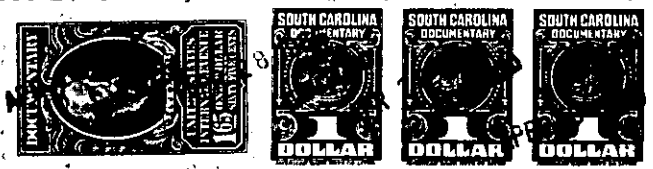

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, lying on the east side of State Highway No. 14, and about three miles north from the City of Greer, S. C., near Mosteller's Mill, being known and designated as tract No. 7, on a Plat of Property made by the Estate of Mamie Mosteller Burnett, Plat No. 1 by J. Q. Bruce, surveyor, dated October 24th, 1953, and having the following courses and distances, to-wit:

BEGINNING at a stake on the eastern side of said highway, joint front corner of tracts Nos. 7 and 6, and in the center of the Duke Power Company right-of-way, and runs thence with the common line of the these tracts and center of right-of-way, N. 68-45 E. 973 feet to a stake; thence S. 21-58 W. 685 feet to a stake, joint corner (rear) of tracts Nos. 7 and 8; thence with the common line of these lots S. 82-39 W. 558 feet to a stake on eastern side of said State Highway; thence therewith N. 16-04 W. 364 feet to the beginning corner, containing Seven and Eighty One-Hundredths (7.80) acres, more or less, and being a portion of tract No. 7 described in deed to the late Mamie Mosteller Burnett, recorded in the R.
