in consideration of the sum of Nine Thousand Three Hundred and No/100 (\$9,300.00)-----DOLLARS,

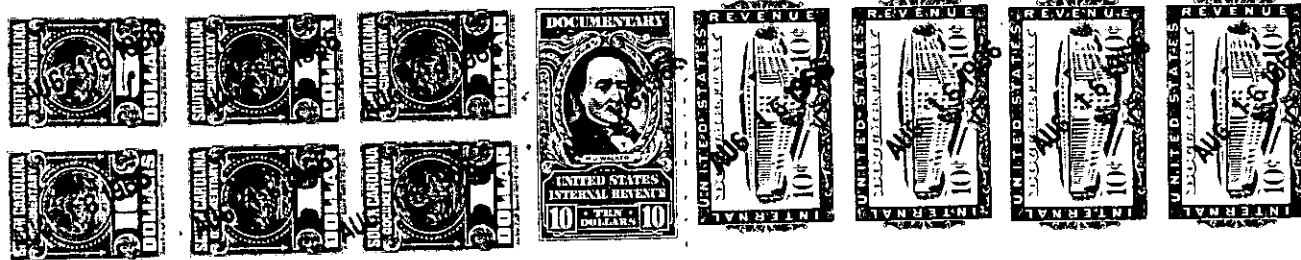
