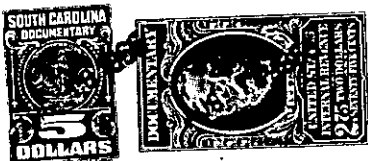
KNOW ALL MEN BY THESE PRESENTS, that CENTRAL REALTY CORPORATION
