In the City of Greenville, having the following metes and bounds:

BEGINNING at an iron pin on the southwest corner of Neal and Townes Streets; thence South 21-30 West 60 feet to an iron pin, corner of Lot No. 8, now owned by Z. A. Smith; on Townes Street; thence with said Lot No. 8, North 76 West 140 feet to an iron pin in line of Lot No. 8 1/2; thence in line of Lot No. 8 1/2 North 21-30 East 60 feet to an iron pin on Neal Street; thence along Neal Street South 76 East 140 feet to an iron pin at the beginning corner; being Lot No. 9, according to a plat made by W. 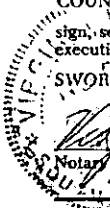
