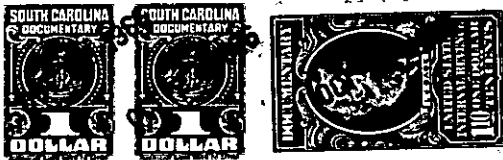

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina in Paris Mountain Township situate on Club Circle Drive, and having the following metes and bounds, to-wit:

Beginning at an iron pin located on Club Circle Drive at the joint front corner of property of the grantors and the grantee and running thence along Club Circle Drive S. 40-55 W. 140 feet to an iron pin on the line of property belonging to Henry Free; thence along the joint line of the grantor's property and the property of Henry Free S. 84-50 E. 248.9 feet to an iron pin; thence N. 6-30 E. 115 feet to an iron pin at the joint rear corner of the grantor's property and property belonging to the grantee; thence along the joint line of said properties N. 84-50 W. 180 feet to an iron pin, the beginning corner.

Being a portion of a 10 acre tract of land conveyed to Ed Robinson by the Independent Guano Company by deed recorded in the R.M.C. Office for Greenville County in Deed Book 194 at page 39.
