MILLER and CARRIE MILLER, their heirs and assigns, forever:

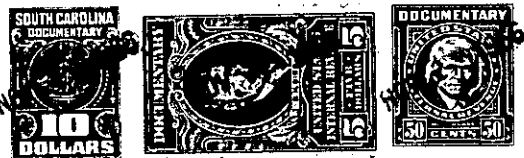
ALL that lot of land with improvements lying on the Eastern side of Blossom Drive in Gantt Township, Greenville County, South Carolina, being shown as Lot No. 29 on a Plat of Kennedy Park, made by Piedmont Engineers & Architects, dated September 28, 1964, revised on January 28, 1966, and recorded in the RMC Office for Greenville County, S. C., in Plat Book JJJ, page 179, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Eastern side of Blossom Drive at the joint front corners of Lots Nos. 28 and 29 and running thence along the common line of said lots, N. 51-13 E., 178.2 feet to an iron pin; thence S. 3-01 W., 180 feet to an iron pin at the joint rear corners of Lots Nos. 29 and 30; thence along the common line of said lots, N. 83-01 W., 118.6 feet to an iron pin on Blossom Drive; thence with the curve of the Eastern side of Blossom Drive, the chord of which is N. 12-27 W., 55 feet to an iron pin, the beginning corner.

The above described property is hereby conveyed subject to utility rights of way and easements shown on the aforementioned recorded plat and appearing of public record and to restrictive covenants applicable to Kennedy Park recorded in the RMC Office for Greenville County, S. C., in Deed Book 773, page 527.

As a part of the consideration for this deed, the Grantees assume and agree to pay in full the indebtedness due on a note and mortgage covering the above described property in favor of Carolina Federal Savings & Loan Association recorded in the RMC Office for Greenville County, S. C., on September 27, 1966, in Mortgage Book 1041, page 420, which has a present balance due in the sum of \$7,300.00 plus accrued interest.

The Grantees agree to pay 1966 Greenville County property taxes.
