BOND FOR TITLE AGREEMENT

Office for Greenville County, South Carolina, in Plat Book WW at page 202, and having, according to said Plat, the following metes and bounds, to-wit:

Two Hundred and NO/100 (\$200.00) Dollars Cash as of the date of delivery of this Bond for Title Agreement, and the balance to be paid, with interest at the rate of six (.06%) per cent per annum, computed annually on the unpaid principle balance and distributed in monthly installments on principle and interest of Forty Four and 73/100 (\$44.73) Dollars to be paid on or before the first day of each and every calendar month hereafter in advance until the full amount of principle with interest has been paid, such monthly payments to be applied first to the payment of the interest, and then to the payment of the principle.
