JOHN L. BARBER, All that parcel of land, in Graceland cemetery, owned by the late Lida Lee Barbre, who is now deceased. Lots no. 1, 2, and 3, & 4. Known as burying Lots. In Lot no. 390. Section no. 8 A. containing 160 Sq. Feet. more or less. And I will abide by all rules and regulations, according to the map which is on file in the office of the Graceland cemetery corporation.

It is distinctly understood that said lot is to be used exclusively for the burial of human bodies of the white race, and is sold and conveyed subject to all rules and regulations printed on the back hereof and any addition or amendments for the government of the cemetery which may hereafter be adopted.

To have and to hold the above granted property to the said John L. Barber. Heirs and assigns, forever, however, to the restrictions and limitations above referred to.

And Graceland Cemetery Development Co. INC: for its self, and successors and assigns, covenants with the said John L. Barber. That the Lots shall receive general care as specified in rule No. 5 on the reverse side hereof to which reference is made. And, Graceland Cemetery Development Co. INC; does hereby binds its self and its successors to warrant and forever defend the said premises to the said John L. Barber, Heirs and assigns against its self and its successor and against every person whomsoever lawfully claiming or to claim the same or any part thereof; subject, however, to the restrictions and limitations herein contained

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)'s heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
