ALL that lot of land with the buildings and improvements thereon, situate on the North Side of Pelham Road about six (6) miles East of the City of Greenville, in Greenville County, S.C., being shown as a portion of Tract 5 on plat of V. Perry Hudson land made by Dalton & Neves, Engineers, November, 1928, and having according to said plat and a survey made by W. J. Riddle, Surveyor, December, 1947, the following metes and bounds, to-wit:
