in consideration of the sum of One Thousand and no/100 (\$1,000.00) ----- DOLLARS, and assumption of the mortgage referred to below, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WILLIAM V. SMART, His Heirs and Assigns, Forever:

ALL that pieve, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being on the South side of Forestdale Drive, near the city of Greenville, in Greenville County, S. C., shown as Lot 58 on plat of Forestdale Heights, made by R. K. Campbell, December, 1956, recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, Page 199, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Forestdale Drive at the joint front corner of Lots 57 and 58, and running thence with the line of Lot 57, S 4-31 W. 196.1 feet to an iron pin; thence N 85-45 W 70 feet to an iron pin; thence with the line of Lot 59 N 4-31 E 196.5 feet to an iron pin on the South side of Forestdale Drive; thence with Forestdale Drive S 85-29 E 70 feet to the point of beginning.

The Grantee herein assumes and agrees to pay the mortgage given by Robert G. Schultz to C. Douglas Wilson & Co., in the original amount of \$13,500.00 dated September 1, 1960, recorded in the RMC Office for Greenville County, S. C. in Mortgage Book 834, Page 547, on which there remains unpaid a balance of \$12,185.82.

This is the same property conveyed to me by deed of Frank P. Hammond and L. A. Moseley, dated October 5, 1962, recorded in the RMC Office for Greenville County in Deed Book 708, Page 268.

This conveyance is SUBJECT to all restrictions, set back lines, roadways, easements, and rights-of-way, if any affecting the above described property.
