Margaret Martin Suber, her heirs and assigns:

All those certain pieces, parcels, or lots of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as the major portion of the Parish Place containing 211 acres as is more fully shown on a plat of property of R. G. Williams dated July 21, 1913 by H. Olin Jones, Architect and Engineer and recorded in the R. M. C. Office for Greenville County in Plat Book D, at Page 19, and being shown on said plat as Tracts Nos. 1 through 8, inclusive, less, however, certain lots of land heretofore deeded by J. Robert Martin, Jr. and J. Robert Martin, Sr. which exceptions are identified on the Township Tax Maps for Greenville County at Sheet 239.5, Block 1, Lots 28, 29, 30, 31, 32, and 35 and also on Sheet 239.4, Block 1, Lots 1, 2, 2.1 and 3.

The property conveyed by this deed is identified on the Township Block Book for Greenville County at Sheet 239.5, Block 1, Lots 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 33, and 34 and on Sheet 239.4, Block 1, Lots 4 and 5.

The 211 acre tract described above was originally conveyed to J. Robert Martin, Sr. by deed recorded in the R. M. C. Office for Greenville County in Deed Vol. 54, at Page 137 and is known as the lower portion of the Williams Estate property. Said J. Robert Martin, Sr. died November 30, 1964 and under his Will dated February 28, 1962, filed in the Office of the Probate Judge for Greenville County in Apt. 890, File 5, the above described real estate was devised to Margaret Martin Suber under Item III of said will and the purpose of this deed is to convey the life estate of the grantor which was reserved in the deed to the within grantee dated Aug. 25, 1966 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 805 at Page 39. The property conveyed by this deed is approximately 165.38 acres, more or less.
