Massey all that piece, parcel or lot of land in the County and State aforesaid within the corporate limits of the City of Greenville, on the East side of Augusta Street, and designated as the Southern half of lot No. 2 as shown on plat of the Parrish & Gower property, which plat is recorded in the R.M.C. Office of Greenville County in Plat Book "E", page 136, and having the following metes and bounds, to-wit:

Beginning at an iron pin on Augusta Street, joint corner of lots #2 and #3 as shown on said plat, and running thence N. 42-07 E. 165 feet to an iron pin on a fifteen foot alley; thence along said alley, N. 53-03 W. 69 feet to an iron pin; thence S. 42-07 W. to a point on Augusta Street; thence along said Augusta Street, S. 47-53 E. 68 1/2 feet to the beginning corner; being the same lot of land conveyed to me by A.W. Hill by deed dated February 7th, 1929 and recorded in Deed Book, Vol 148, page 254, R.M.C. Office of Greenville County.

The depth dimensions of the above described property are subject to right-of-way encroachments across the front on Augusta Street by the S.C. Highway Dept. This property is located at 1311 Augusta Street as of this date.
