FOR AND IN CONSIDERATION of the sum of \$ 1.00 to the undersigned in hand paid by the City of Greenville, S. C., the receipt whereof being hereby acknowledged, (I) (we) hereby grant unto said City of Greenville, a right-of-way or easement along, over or under (my) (our) property for the purpose of: Installing and maintaining sanitary sewer lines, with two manholes, said right of way to extend 15 feet on each side of the center line during construction and a permanent right of way of five feet on each side of the center line of said sewer line as installed, and being 35 feet, 40 feet, 25 feet and 25 feet, more or less, in length respectively.

Together with the right of ingress and egress for the purpose of inspecting and maintaining the same.

Said property is described as follows: Located in the City of Greenville, being shown and designated as Lots 2, 3, 4, and 5 of a Subdivision known as Barksdale, a plat of which is recorded in Plat Book QQ at Pages 118 and 119 in the R. M. C. Office for Greenville County, said lots being situate on the Southeastern side of Windmont Road.
