ALL those certain pieces, parcels or lots of land with improvements thereon, situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as LOTS Nos. 22, 23, 24, 25, 26 and 27 on the Southwest side of Piney Mountain Road and being shown on plat thereof of subdivision known as Paris Piney Park as recorded in the RMC Office for Greenville County in Plat Book H, at pages 19 and 20 and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southwest side of Piney Mountain Road at joint front corner of Lots 27 and 28 and running thence along Piney Mountain Road, N. 25-12 West 58.1 feet; running thence North 32-31 West 54.8 feet; running thence N. 40-57 West 51.2 feet; running thence N. 53-28 West 50.1 feet; running thence N. 57-14 West 100 feet to the joint front corner of Lots 26 and 22; running thence S. 34-30 West 215 feet to an iron pin at joint front corner of Lots 22 and 21 on Apopka Avenue; running thence along Apopka Avenue, S. 55-30 East 300 feet; running thence N. 34-30 East 146 feet to an iron pin, the beginning corner.

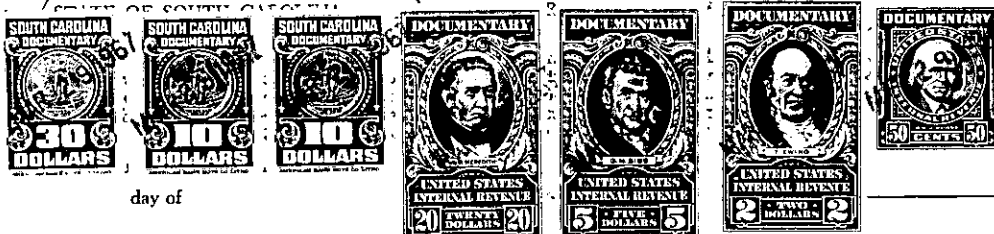
