KNOW ALL MEN BY THESE PRESENTS, that I, OLIS GARVIN CHASTAIN

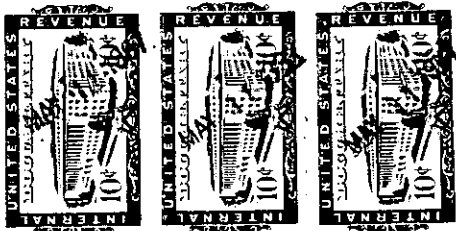
in consideration of THIRTEEN THOUSAND AND NO/100ths (\$13,000.00) ----- Dollars,
