All that piece, parcel, or lot of land in the County of Greenville, State of South Carolina, being shown as Lot No. 64, on plat of Section III, Wade Hampton Gardens, recorded in the RMC Office for Greenville County, S. C., in Plat Book "YY", at Page 179, and being described as follows:
