Nine of Lot No. 103 S. 2-09 E. 275. 2 feet to an iron pin; thence N. 77-48 E. Nine of Lot No. 101 S. 87-30 E. 193 feet to stone; thence S. 87-30 E. 193 feet to stone; thence S. 86-45 E. 107. 2 feet to stone at rear corner of Lot No. 101; thence along line of Lot No. 101 N. 3-15 E. 210 feet to the point of beginning.

The within conveyance is subject to the easement and right-of-way of the power line of Duke Power Company across a portion of the property herein conveyed.
