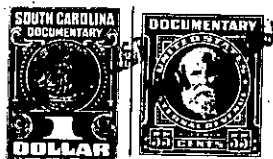

ALL THAT piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, on the western side of Monteith Circle, being known and designated as Lot No. 9 on plat of PROPERTY OF O. Y. BROWNLEE, H. C. SMITH and C. S. FOX, according to plat recorded in the RMC Office for Greenville County in Plat Book "Q", at Page 164. According to said plat the property is more fully described as follows:
