the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto JAMES COOLEY, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, about 7 miles Southwest of the City of Greenville, and being known and designated as Lot Number 5 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book 000 at Page 95, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of South Carolina Road Number 106 at the joint front corner of Lots 4 and 5 and running thence with the Southwestern side of S. C. Road Number 106 S 48-46 E 185 feet to a point; thence following the curvature of the Southwestern intersection of S. C. Road Number 106 with a proposed street (the chord of which is S 2-58 E) 34.8 feet to a point; thence with the Northwestern side of said proposed street S 42-50 W 225 feet to a point at the rear corner of Lot 5; thence N 48-45 W 196.3 feet to a point at the rear corner of Lot 5; thence N 39-45 E 250 feet to a point on the Southwestern side of S. C. Road Number 106 at the point of Beginning.
