the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Otis D. Gorman and W. E. Curry, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the southeastern side of Mulberry Street and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Mulberry Street approximately 119 feet in a southwesterly direction from the southwestern corner of the intersection of Mulberry Street and Hampton Avenue and running thence S. 35 E. 106 feet, more or less, to a stake; thence S. 55 W. 50 feet, more or less, to a stake; thence N. 35 W. 106 feet, more or less, to a stake; thence along the southeastern side of Mulberry Street in a northeasterly direction 50 feet, more or less, to the point of beginning.

The above is the same property conveyed to Mary L. Fisher by deed recorded in Deed Book 124, at Page 424 and devised to the grantor's mother, Josephine Fisher, for life and then to the grantor by Will of said Mary L. Fisher.
