these presents do grant bargain, sell and release unto the said Carroll Lee Henson and his heirs and assigns forever:

State of South Carolina, located about seven miles north of the City of Greer and about one-half mile north of the Old Berry's Mill, lying on the west side of State dighway No. 14, being shown on a plat of property made for the T.M. Stokes Estate by J.Q. Bruce, Surveyor, dated March 27, 1967, to be recorded herewith, and having the following courses and distances:

BEGINNING on a stake in the center of said State Highway No. 14 (iron pin on west bank thereof at 18 feet from true corner), corner (iron pin on west bank thereof at 18 feet from true corner), corner with Ralph Henson's land, and runs thence along the center of said highway, S. 9-28 E. 556.9 feet to a stake (iron pin on west bank of highway at 28.4 feet from true corner); highway at 28.4 feet from true corner); thence S. 81 W. 1116.4 feet crossing three iron pins to another pin; thence S. 88 W. 674.5 feet crossing an iron pin to another iron pin in Beaverdam Creek; thence along and with the meanders of said creek as the line, N. 34-39 E. 169.7 feet to a stone on west bank of creek (old corner); thence with the line of L.A. Forrester, N. 17-42 E. 495 feet to an iron pin; thence with Ralph Henson's line, S. 63-23 E. 467.8 feet to an iron pin and N. 73-20 E. 1061.4 feet to the beginning corner, containing 18.5 acres more or less, bounded by lands of Ralph Henson on the north, said highway on the east, lands conveyed to Alvin Stokes, et al on the south, and on the west by lands of L.A. Forrester and lands now or formerly owned by Ruth P. Forrester.
